## WHAT ARE COOKIES

Cookies are small text files that are used to store small pieces of information. They are stored on your device when the website is loaded on your browser. These cookies help us make the website function properly, make it more secure, provide better user experience, and understand how the website performs and to analyze what works and where it needs improvement. ## HOW WE USE COOKIES

As most of the online services, our website uses first-party and third-party cookies for several purposes. First-party cookies are mostly necessary for the website to function the right way, and they do not collect any of your personally identifiable data.

Panonian rarely uses third-party cookies. However, if applied, the third-party cookies used on our website are mainly for understanding how the website performs, how you interact with our website, keeping our services secure, and all in all providing you with a better and improved user experience and help speed up your future interactions with our website.

## WHAT TYPE OF COOKIES WE USE

There are a number of different types of cookies, however, our website uses:

**Essential** – These cookies are absolutely necessary for you to be able to experience the full functionality of our site. They allow us to maintain user sessions and prevent any security threats. They do not collect or store any personal information. For example, these cookies allow you to log-in to your account and add products to your basket, and checkout securely.

**Functional** – These are the cookies that help certain non-essential functionalities on our website. For example this category contains cookies that help us store your settings and browsing preferences like language preferences, location you are in and/or keeping you logged in so that you have better and easier future interactions with our website. It also includes cookies for embedding content like videos or sharing content of the website on social media platforms. A mix of first-party and third-party cookies are used.

**Performance** – These are the cookies that are used to understand and analyze the key performance indexes of the website which helps in delivering a better user experience for the visitors.

**Analytics** – These cookies store information like the number of visitors to the website, the number of unique visitors, which pages of the website have been visited, the source of the visit, etc. These data help us understand and analyze how well the website performs, how visitors interact with the website, and where it needs improvement.

An overview of the cookies we collect can be found below:

COOKIE	DESCRIPTION
_gat	This cookie is installed by Google Universal Analytics to restrain request rate and thus limit the collection of data on high traffic sites.
caosLocalGa	This cookie is used to determine whether the browser accepts cookies. It expires when we close the browser.
caosLocalGa_gid	This cookie is used to count how many people use the website in a day.
wordpress_test_cookie	This cookie is set by our website to test if cookies can be set on your browser.
wordpress_sec_*	Used by our website in order to provide protection against hackers, track the user's authorisation to each access resource and store account details.
wordpress_logged_in_*	This cookie is used by our website to keep the user logged-in.
cookieLawInfo-checkbox-analytics	This cookie is set by GDPR Cookie Consent plugin. The cookie is used to store the user consent for the cookies in the category "Analytics".
cookieLawInfo-checkbox-functional	The cookie is set by GDPR cookie consent to record the user consent for the cookies in the category "Functional".
cookieLawInfo-checkbox-necessary	This cookie is set by GDPR Cookie Consent plugin. The cookies is used to store the user consent for the cookies in the category "Necessary".
cookieLawInfo-checkbox-performance	This cookie is set by GDPR Cookie Consent plugin. The cookie is used to store the user consent for the cookies in the category "Performance".
CookieLawInfoConsent	The cookie is set by the GDPR Cookie Consent plugin and is used in combination with viewed_cookie_policy to store whether or not user has consented to the use of cookies. It does not store any personal data.
viewed_cookie_policy	The cookie is set by the GDPR Cookie Consent plugin and is used to store whether or not user has

	consented to the use of cookies. It does not store any personal data.
store_notice[notice id]	Allows customers to dismiss the WooCommerce "Store Notice". No personal information is stored in this cookie.
woocommerce_cart_hash	Helps WooCommerce determine when cart contents/data changes.
woocommerce_items_in_cart	Helps WooCommerce determine when cart contents/data changes.
woocommerce_recently_viewed	Powers the WooCommerce "Recent Viewed Products" widget.
wp_woocommerce_session_	Contains a unique code for each customer so that it knows where to find the cart data in the database for each customer.
wp-wpml_current_language	Stores the current language. This cookie is enabled by default on sites that use the Language filtering for AJAX operations feature.
popup_close_remember	This cookie is used to remember that the visitor has seen the displayed pop-up, so that it won't be displayed again.

## HOW TO CONTROL YOUR COOKIE PREFERENCES
